3. Consultations

- New Forest District Council Local Plan Review 2016-2036 at the beginning of the summer NFDC consulted on the soundness of the pre-submission draft of the Local Plan Part 1: Planning Strategy. The attached response was sent on behalf of the Forum, together with a copy of the Forum's 'Guidance on Access for Planners and Developers'.
- New Forest Inclosures Deforestation Proposals the following email was sent to the Forestry Commission in response to this consultation:

Dear Sirs,

The New Forest Access Forum (the Local Access Forum for the whole of the New Forest National Park and New Forest District and a statutory advisory body under the Countryside and Rights of Way Act 2000) would like to thank the Forestry Commission for the opportunity to comment on the Forest Enterprise application for consent to deforest approximately 464 hectares of woodland in the New Forest and return it to open heathland under the Environmental Assessment (Forestry) Regulations 1999.

The Forum does not consider it has the expertise to comment in any detail on this application, but supports the proposal in principle as part of a long-term Forest Design Plan to move from softwood production to hardwood and open heath. In that context, we suggest that any future consultation some other term should be used than 'deforestation', which has negative connotations that do not reflect the benefits of this work to both landscape and habitats within the New Forest.
